In the past year, there have need many improvements made to the Sharing Shop to make it an even better place to shop, work and volunteer. We are blessed to have a very dedicated group of volunteers in the store that have been with us for many years and this last year has seen a number of new volunteers join us. They all work very hard to make sure our shoppers have a great experience with lots of merchandise to choose from. I hope all our volunteers old and new alike enjoy their time with us.

One of the priorities always at the top of the list is creating space and displaying merchandise in an efficient and appealing way. New specialty racks, both on the floor and out back have helped us display merchandise better and maximize all the available space we have.



Another priority in 2022 was to make sure our pricing is reasonable ensuring revenues increase while maintaining great prices for customers. Careful consideration was given to items that required modest adjustments. Given the increase in sales over the previous year, I would say this was accomplished well.

The highlight of the year had to be Santa's Workshop for the kids. It was something I had done before and thought it would be a good fit for us and the community. It's designed to offer some assistance to children (no parents allowed) who can shop in the store for one evening for their family. They bring whatever money they have and a list of whomever they are shopping for and no matter how much money the child has, everyone on their list gets a present. Our volunteers stepped up to the plate and helped out as elves making sure the children had someone to accompany them and their gifts were wrapped. # From the Office



As everyone is aware, 2022 saw inflation drive food prices and other necessities to a painful level. As a result, we have seen greater numbers of families, especially with children, access services from the food bank. Most of these families have never used a food bank before. We exceeded the budget for food and lunch programs by approximately \$22,000 in order to cover the increased need in the community.

Funding levels remain stable and store sales have increased. We are in an encouraging position financially which has allowed us to meet the rising demand and continue to provide needed assistance at existing levels.

With help from a Regional Development Corporation grant, we were able to update old, unused office space and the existing lobby to create a new Board room, entry, and storage space. We finished the food room with new flooring and shelving. The new shelving has increased storage to such an extent that almost all the food we stock is able to be stored in the main food room.



We developed a new partnership with Child and Youth services to provide an emergency pantry and help for youth living in temporary arrangement conditions. This crucial service allows us to reach children that would not otherwise have access through normal channels of outreach. The Sharing Club and its members should be very pleased with the progress we have made in our level of outreach and impacts on children and youth in the community.

Moving forward, we have plans to improve our working conditions for our volunteers with a new space intended to allow them to have a place to relax, eat, and share, while here. We hope to finish up renovations to food side spaces with a kitchen suitable for handling bulk food items, meal prep, avoid allergen contamination and other considerations for safe food handling.
